

State Fair Concert Ticket Promotion #2
OFFICIAL RULES AND CONDITIONS OF ELIGIBILITY

OVERVIEW:

ENTRY REQUIREMENTS:

- Must be following @delottery
- Like the photo in the Instagram posting
- Tag who you'd bring with you to the concert in the comments.

Must be a US Resident and 18 years of age or older.

One winner will be selected on Friday, July 19, 2024 and will be notified via DM directly from the Lottery account.

Only registered Members who are 18 years of age or older may participate. Entries are limited to only one (1) Entry per person, Only one person per household may win; no person may win more than one time.

The Entry deadline for the Promotion Period will be 11:59:59 PM on Thursday, July 18, 2024.

Entries are limited to only one (1) Entry per Instagram account during the Promotion Period. Additional comments from the same Instagram account during the Promotional Period will not count in the Promotion. All times in this Promotion's Official Rules and Conditions of Eligibility ("Rules" or "Official Rules") are Eastern Time

The claiming deadline for the winner is by 4:00 PM on Monday, July 22, 2024. ("Alternate" or "Alternates") must claim by 4:00 PM on Tuesday, July 23, 2024.

You do not have the option to request or receive a substitute or equivalent prize, including cash, for any Prize.

OTHER OFFICIAL GAME RULES:

By entering this Promotion, each winner agrees to the following:
